COVID-19 and Mental Health

COVID-19 has dramatically increased mental health needs.

- The Centers for Disease Control and Prevention (CDC) now tracks mental health needs weekly. As of mid-February 2021:
 - Symptoms of anxiety disorder up 4-fold (33.8% vs 8.2%)
 - Symptoms of depression up 4-fold (27.9% vs 6.6%)
- The number of people <u>seriously considering suicide doubled</u>.
- Mid-March through October 2020, the proportion of mental health-related ED visits increased 24% among children aged 5–11 and 31% among adolescents aged 12–17.
- A November 2020 Lancet study found <u>mental illness</u> increases the risk of COVID 65% and COVID <u>causes more</u> mental illness.



COVID-19 and Mental Health: Projections

In April 2020, we began a series of reports projecting the mental health impacts of the pandemic.

- Our original projections suggested that for every <u>5%</u> increase in the unemployment rate compared to prepandemic levels, an additional <u>4,000 Americans</u>, including <u>300 Texans</u>, could be lost to suicide.
- Multiple national groups and media sources
 (Washington Post, Wall Street Journal, CNN) have used our estimates.
- No statistical models are right, but some can be useful.




The Legislature Is Stepping Up

Now, more than ever, we must <u>protect the investments and</u> <u>work</u> of the Texas Legislature and Texas communities.

- 1115 waiver extended through September 30, 2030.
- HB 1 and SB 1 provide over \$8 billion for behavioral health.
- Mental Health Grant Programs are fully funded:
 - <u>Justice-Involved Individuals</u> (\$60 million)
 - Texas Veterans + Family Alliance (\$20 million)
 - Community Mental Health (\$40 million)
 - Healthy Community Collaboratives (\$25 million)
- SB 1 provides an additional \$19.5 million to the <u>Texas Child</u> Mental Health Care Consortium.





1. Secure Access Gains Through Telehealth

COVID-19 has modernized the treatment dynamic.

 Since March 2020, HHSC has authorized <u>certain behavioral</u> <u>health services</u> to be reimbursed in <u>Medicaid</u> when delivered by <u>telemedicine</u>, <u>telehealth</u>, or <u>telephone</u>.

The Subcommittee must adopt a budget rider to maintain this access for the biennium, at a minimum.

HB 4 (Price) would ensure permanent access.

Claims for Telephone (Audio Only) Behavioral Health Services

Note: Texas Medicaid managed care organizations (MCOs) must provide all medically necessary, Medicaid-covered services to eligible clients. Administrative procedures such as prior authorization, pre-certification, referrals, and claims/encounter data filing may differ from traditional Medicaid (fee-for-service) and from MCO to MCO. Providers should contact the client's specific MCO for details.

To help ensure continuity of care during the COVID-19 (coronavirus) response, HHSC is authorizing providers to submit claims for dates of service March 20, 2020, through April 30, 2020, for reimbursement of the following behavioral health services delivered by telephone (audio only):

To indicate the occurrence of remote delivery, providers should continue to use the 95 modifier.



2. Implement Collaborative Care in Medicaid


<u>Collaborative Care</u> (CoCM) is a proven, team-based approach to detect and treat mental illness in <u>primary care</u>.

Coverage: Medicare since 2017, commercial since 2019

 Cost saver: Up to 6 to 1 in total medical costs in Medicare and Medicaid settings and an estimated \$15 billion in Medicaid savings if only 20 percent of beneficiaries with

depression receive it.

 Our Texas models suggest universal access to CoCM to treat major depression could reduce suicide deaths by 725 to 1,100 per year.

3. State Hospital System Redesign: Phase III

Construction Requests

- Austin State Hospital \$124.1 million
- San Antonio State Hospital \$152.4 million

Operations Requests

- Kerrville State Hospital (70 MSU beds) \$29.3 million
- UTHealth Behavioral Sciences Center \$52.1 million
- San Antonio State Hospital (40 beds) \$16.7 million ✓





4. Continue to Scale-Up the Consortium

The <u>Texas Child Mental Health Care Consortium</u> is critical to early intervention and the wellness of Texas children.

- Child Psychiatry Access Network (CPAN) saw a 62% increase in calls from providers in October 2020 and another 40% increase in calls in November 2020
- Texas Child Health Access Through Telemedicine (TCHATT) –
 covered <u>1,124 schools</u> as of October 2020. Currently, <u>more</u>
 than <u>1.5 million Texas students</u> can access the program.
- Workforce Expansion partnerships with 17 community mental health providers are augmenting the delivery of public mental health services
- Funded under Article III
