

OUR CHALLENGE

COVID-19 has exacerbated the nation's growing mental health crisis, overwhelming school districts as they work to meet the needs of students and educators throughout the ongoing pandemic.

THE SOLUTION

Effective school mental health programs are critical to improving student outcomes, well-being and academic achievement.

The Meadows Mental Health Policy Institute is leading a **10-month, premiere learning experience** that will equip districts to **effectively execute school mental health programming.**

PROJECT GOALS

- Develop successful school-based mental health programs in North Texas
- Increase access to mental health care by leveraging the school system
- Increase the early identification and treatment of presenting child and adolescent mental health conditions, specifically depression and anxiety
- Foster collaboration between district leaders and community partners

Comprised of executive leaders from 19 school districts, the North Texas School Mental Health Executive Learning Community (ELC) will meet monthly from April 2022 through January 2023 to participate in expert-facilitated learning sessions, peer networking, thought partnership, collaborative problem solving, and discussion on all things school mental health. In addition to hearing from an expert speaker each session, the ELC members will also be introduced to leaders from local community providers and philanthropic partners to help further expand each district's professional network and reach. This group will set the tone and lead the way for the future of school mental health in Texas.

Additionally, 5 of the 19 districts have been selected to receive additional benefits through the Meadows Institute as part of our **Intensive Implementation Cohort**. This elite cohort will receive all sessions and benefits of the larger ELC and will also have the special opportunity to take a deeper dive into implementation planning. In addition to other benefits, these 5 districts will receive monthly consultation and technical assistance from the Meadows Institute. Each school district in the Implementation Cohort will receive customized coaching support as they develop an implementation plan to support the launch of a new school mental health initiative.
