The program aims to provide interns with experience in quality, nonpartisan, and objective policy research and development to improve mental health services in Texas.

In our experience, students who benefit the most from these internships are further along in their studies related to our mission, have exceptional writing and critical thinking skills, and have a wide range of diverse experiences that contribute uniquely to our mission, including lived experience with mental health issues and multicultural or cross-cultural experiences. Students who are either currently enrolled in a master's or doctoral program, or individuals who possess a bachelor's degree with at least two years of professional work experience are encouraged to apply. The summer internship runs from June 1, 2023 to August 4, 2023 and will be conducted remotely, with some positions offering in-person opportunities regionally. Interns receive stipends for their participation, and we can work with students to meet credit-earning requirements. Interns must make a full-time, 10-week commitment to maximize their exposure to the Institute's work and enhance their professional development. It is not feasible for interns to concurrently hold another full-time position.

Students who are interested in applying for an internship should send a signed cover letter, résumé, and three references (please do not send letters of recommendation) to: <u>internship@mmhpi.org</u>. The cover letter should describe their interest in the internship, identify one or more areas of focus from the list above, if they will be pursuing credit-earning requirements, and note any requests for time off for vacation or other personal business during the internship.

**Application materials will be accepted until March 31, 2023.** We will begin conducting phone screenings with selected applicants the week of April 10, 2023. The internship position may not be filled or performed in California, Colorado, Montana, Rhode Island, or Washington at this time. Successful candidates must show proof of eligibility to work in the United States. The internship position is not benefits eligible.
